Agreement to the following

I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Impact Nations Leadership. I am in sufficiently good health for travel and have all the vaccinations specified for travel to the above destination by the World Health Organization and/or my country, province or state health department. *(This information is on the Web. If in doubt, call our office.)*

Assumption of the risks and release.

I know that International travel for ministry and/or missions involves danger and risk. I acknowledge that the dangers and risks include, but are not limited to, the hazards of travel by all means of conveyance and in all environments and political situations; sickness or injury in areas where medical assistance may be primitive, inadequate, or not readily available, and/or where rapid evacuation is not available; or where there is exposure to crime, to civil unrest and to forces of nature or other dangers.

Assumption of the injury and release.

I acknowledge that Impact Nations does not accept any responsibility for injury, illness or loss suffered by me, and that all medical or personal expenses in connection with or made necessary by my illness or injury or loss on this trip are my own responsibility. Impact Nations includes in the cost of the Journey, medical insurance for your time on this Journey but it is your responsibility to file any paperwork needed to file a claim. Should I become ill or injured or suffer other damage, I will pay all costs involved including costs of evacuation and medical care I might receive.

No duress.

I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review it before signing. I further agree and acknowledge that I am free to have my own legal counsel review this Agreement if I so desire.

Dispute resolution.

The parties will attempt to resolve any dispute arising out of or relating to this Agreement thorough friendly negotiations amongst the parties. Any controversies or disputes arising out of or relating to this Agreement well be submitted to Mediation in accordance with any statutory rules of mediation. If mediation does not successfully resolve the dispute, then the parties may proceed to seek an alternative form of resolution in accordance with any other rights and remedies afforded to them by law.

TEAM UNITY AGREEMENT

Welcome to the Team! You have joined in this adventure to make a lasting difference in the lives of poor and unreached peoples, and to stretch yourself spiritually. We honor your sacrifice of time and finances, and your courage in stepping out of your 'comfort zone'! This Unity Agreement simply clarifies our mutual expectations and gives us permission to speak into a situation that is affecting you or any of the Team or any of the people to whom we will be ministering. Our Unity is a major part of our message (John 17:23).

PURPOSE:

You understand that this Journey of Compassion is in no way a vacation or for your benefit. You are going as an agent of Impact Nations to fulfill its mandate of rescuing lives and transforming communities in the developing world.

MINISTRY:

The Impact Nations methodology of training, praying, healing and evangelism is entirely biblically based. The team will receive training, ministry, and impartation during the first one or two days of the trip in order to understand and use these methods. If you intend to be part of the Ministry Team, you agree that you will attend this training time, and that you follow the methods as taught so that your ministry has maximum effectiveness.

CARE TEAMS:

You will be assigned to a Care Team with five or six other members and a Care Team Leader. The Care Teams will meet to compare notes, ask questions, eat together, and to encourage and pray for one another. You agree to make every effort to attend and participate in these meetings for your benefit and for theirs. (Hebrews 10:24; Proverbs 18:1)

BEHAVIOR:

In order not to offend our hosts, the people we minister to, or our fellow team members, Impact Nations asks that team members refrain from drinking alcohol while at the Journey destination. It may also be necessary to dress in a conservative fashion, legs and arms covered at some locations or for the whole trip. Guidelines will be published before the trip.

CONFLICT RESOLUTION:

In the unlikely event that a conflict or behavior issue arises that doesn't quickly respond to loving and redemptive correction, we proceed on the basis of Matthew 18:15-17.

- ❖ We believe that if you have a problem with anyone you are to go to that person, without spreading the issue among team members. Attempt to bring understanding and resolution. If it is with someone of the opposite sex, it's best to talk with him or her in a place where others are nearby but cannot hear. Many times, what you consider a problem is only a misunderstanding and bringing it to their attention often brings resolution. Usually this is all that's needed.
- ❖ If that doesn't work, please bring the issue to your Care Team Leader. The Team Leader will work with you both and act as an intermediary to bring resolution. This happens rarely.
- ❖ If the problem is still not resolved after step 2, the Care Team Leader will involve someone from the leadership team and one more attempt will be made to resolve the problem with the parties concerned. If this still is ineffective, the member(s) causing the issue will not be permitted to participate in any aspect of ministry or service. This has never yet been necessary.
